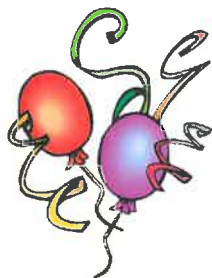

Oatmeal Surprise Cookies

- 1 c. butter, softened
- 1 c. sugar
- 1 c. brown sugar, packed
- 2 eggs
- 1 t. almond or caramel-pecan extract
- 2 c. all-purpose flour
- 1 t. baking soda
- 1 t. salt
- 1-1/2 t. cinnamon
- 3 c. quick-cooking oats, uncooked
- 1-1/2 c. chocolate-covered raisins

Blend together butter and sugars. Beat in eggs, one at a time; stir in extract. In a separate bowl, combine flour, baking soda, salt and cinnamon; stir flour mixture into butter mixture. Mix in oats; fold in raisins. Form dough into walnut-size balls; place 2 inches apart on ungreased baking sheets. Bake at 375 degrees for 8 to 10 minutes. Allow cookies to cool on baking sheets for 5 minutes; transfer to a wire rack to cool completely. Makes 2 to 3 dozen.

Apple Cake

- 1 c. oil
- 2 c. sugar
- 2 eggs, beaten
- 2-1/2 c. all-purpose flour
- 1 t. baking soda
- 1 t. salt
- 1 t. cinnamon
- 2 t. vanilla extract
- 3 c. Golden Delicious apples, cored and chopped
- 1 c. chopped pecans or walnuts
- Optional: powdered sugar

Combine oil and sugar in a bowl; add eggs and blend well. In a separate bowl, mix flour, baking soda, salt and cinnamon; add to oil mixture and blend well. Stir in vanilla, apples and nuts. Batter will be very stiff. Spoon into a greased and floured tube pan. Bake at 350 degrees for 50 to 60 minutes. Turn out cake. Sprinkle with powdered sugar, if desired. Serves 16-20.

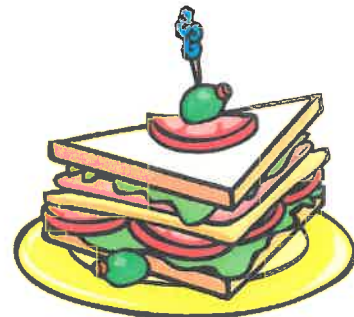

Picnic in a Pan

4 potatoes, peeled and cubed
4 ears sweet corn, broken in half
4 tomatoes, sliced
4 green peppers, sliced
1/2 lb. whole mushrooms, trimmed and halved
1 lb. smoked pork sausage, quartered
1/2 c. butter, sliced
1/2 c. water
1/2 c. Worcestershire sauce
seasoned salt to taste

Layer vegetables and sausage on a 24-inch piece of heavy-duty aluminum foil. Dot with butter. Drizzle with water and Worcestershire sauce. Add seasoned salt to taste. Fold up sides of foil; seal into a packet. Grill over medium heat for about one hour, until vegetables are tender. Serves 4.
