This year, the Nebraska Legal Professional's Association will award its scholarship in the amount of \$1,250.00 to a Nebraska high school or college student who wishes to further his or her education in law or the legal support field at an institution of higher education and who carries a cumulative 2.5 GPA (on a 4.0 scale). We also will award a second-place scholarship of \$750.00. An alternate candidate is also chosen.

All applications must be postmarked on or before March 31, 2019. All applicants must be enrolled part-time or full-time in paralegal, legal secretarial, criminal justice, or any law-related undergraduate program. A check for \$625.00 for the first-place winner and a check for \$375.00 for the second-place winner will be issued to the institution each semester after verifying the students are full-time and taking the required classes. If the first-place winner, for any reason, withdraws from school or does not meet the class criteria mentioned above, we will forward the first-place scholarship award to the second-place winner. The second-place winner's scholarship award will then be forwarded to the alternate candidate.

Please post the enclosed announcement in a prominent place and possibly even initiate contact with any student you think would meet our criteria. Feel free to photocopy as many application forms as you and your students may need.
